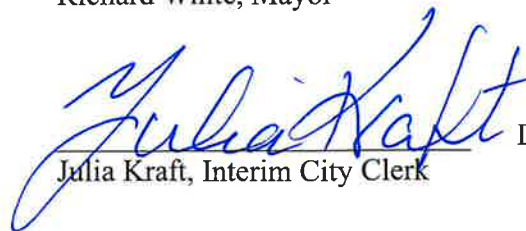

- Update from the hiring committee

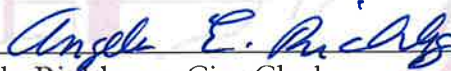
